



Winterbrook Farm's Sunflower Festival and Winterbrook Farm's Fall Festival & Pumpkin Patch Photography Policy

Effective June 2020

FRIENDS AND FAMILY PHOTOS (non-paid photographers):

We welcome amateur visitors to:

- Take photos during business hours only. No one is allowed on Winterbrook Farm's property after business hours unless it is by appointment
- Everyone entering Winterbrook Farm's property must purchase a daily admission wristband.
- Use a camera or cell phone
- Take photos on any public part of the farm

We ask you NOT to:

- Enter any of the areas marked No Access, Do Not Enter, or areas with working farm equipment
- Disturb flowers, vegetation, crops, displays, etc.
- Bring any kind of PETS for your photo

PROFESSIONAL PHOTOGRAPHERS:

We welcome those who wish to use Winterbrook Farms as a backdrop/setting for any portrait/commercial photography, even if the photographer is not compensated, financially or otherwise. We require a reservation, made at least 48 hours in advance. The photographer must also purchase a Winterbrook Farms Seasonal Photography Pass. This may be purchased through our online ticketing website:

- Portrait photography is defined as, but not limited to: senior, engagement, family, graduation, wedding, etc.
- Commercial photography is defined as, but not limited to: catalog, fashion, advertisement, promotion, etc.

Where to check-in and check-out:

Our Ticket Building. Please pick up your lanyard prior to your first session each day and return your lanyard to our admissions booth at the end of each visit.

Reservation/Permit/Photo Waiver/Lanyard/Props

- Reserve all photo sessions at Winterbrook Farms at least 48 hours prior to your session.
- Purchase a 2020 Season Photography Pass. The photography pass is \$50.00 and is good for any day that Winterbrook Farms Sunflower Festival or Winterbrook Farms Fall Festival & Pumpkin Patch is open to the public in 2020. This pass must be purchased through our online ticketing website (Winterbrookfarms.Mazeplay.com) prior to making a reservation for the first session. This pass is for use by the photographer named on the pass and may not be shared with anyone else.
- Anyone assisting the photographer must pay for a daily admission wristband.
- Everyone entering Winterbrook Farms must purchase a daily wristband. This includes people who are being photographed and anyone accompanying them for their session.
- A lanyard will be provided the day of each photoshoot and must be clearly displayed at all times while on Winterbrook Farm's property.

Photography session times:

- Photography sessions can take place during our regular business hours. (guests have to purchase admission)
- Any sessions outside of regular farm hours requires an appointment. (Admission will NOT be charged but no activities will be available)

Locations

- You can only access the PUBLIC parts of the farm. (Ex. Fields. No admission into any buildings)

- You may NOT enter any areas marked No Access, Do Not Enter, or areas with working farm equipment.

Farm Rules: We are a farm first... we want to honor and respect the land and the crops we are growing. Please help us do that.

- Please respect the natural environment and the crops we are growing.
- Use care and caution around landscaping.
- Please supervise all children at all times. This includes photographer's own children while on Winterbrook Farms property. Also, ensure they are not injuring plants and items that are growing in any way.
- Nothing may be picked and used during your session. Sunflowers (during the Sunflower Festival) and pumpkins (during the Fall Festival) are available for purchase.
- Multiple clothing changes on site are not appropriate as these can interfere with our other guests.
- Vehicles are NOT allowed under any circumstances.
- All props must be carried to your photoshoot location. Props or equipment that cannot be carried easily should not be used.
- All props must be removed upon departure.
- We require that all trash be removed from photo site.
- Absolutely NO PETS are permitted on the farm for photos.

Important Reminders

- The use of drones is strictly prohibited.
- All photos should be family friendly in nature.
- No public area may be closed or blocked to customers during regular business hours during a photoshoot.
- Please be courteous and polite to all visitors and customers.
- Our staff is not responsible for directing clients to your photoshoot location. Make sure your clients have your cell phone number so that they can contact you upon their arrival.
- Winterbrook Farms reserves the right to halt any photography sessions deemed to be disruptive.
- Winterbrook Farms assumes no responsibility for loss, theft, or damage to any equipment or belongings.

Any unauthorized portrait/commercial photography sessions will be escorted from the farm.
