



Winterbrook Farms Photography Policy

Effective June 2021

WEEKEND BUSINESS HOURS:

We welcome amateur visitors and/or professional photographers to visit our farm to take photos.

- You may visit during our weekend business hours on Fridays, Saturdays, and Sundays. No one is allowed on Winterbrook Farms property after business hours unless it is by reservation.
- Everyone entering the Winterbrook Farms property must purchase an admission ticket, including the photographer.
- You may use a camera or cell phone.
- You may take photos on any public part of the farm.

Rules:

- Do NOT enter any of the areas marked No Access, Do Not Enter, or areas with working farm equipment.
- Do NOT disturb flowers, vegetation, crops, displays, etc. including sunflowers and pumpkins. Nothing may be picked and used during your session, unless you are paying for it.
- Please be courteous and polite to all visitors and customers, and our staff. No public area may be closed or blocked to customers.
- Absolutely NO PETS are permitted on the farm for photos.
- Any session deemed disruptive or inappropriate will be asked to leave.

PROFESSIONAL PHOTOGRAPHER SESSIONS:

We offer exclusive evening sessions for those who wish to use Winterbrook Farms as a setting for any portrait/commercial photography, even if the photographer is not compensated, financially or otherwise. We require a reservation to be made through our ticketing website: www.WinterbrookFarms.mazeplay.com

Photography Session Times:

- Sessions will be Thursday evenings during our 2021 season from 5:00pm to 7:30pm (2.5 hours). The cost is \$20 per session.
- You may have multiple clients during the 2.5 hour window.
- Approximate dates for use of the Sunflower Field:
 - September 9th, 16th, and possibly the 23rd if still in bloom
- Approximate dates for use of the Pumpkin Patch:
 - September 23rd and 30th, and October 7th and 14th

Check In:

- Please park in our Farm Market parking lot and check in at the market. We will make sure that we have your reservation on our schedule.

Locations:

- Sessions are to take place in our sunflower or pumpkin fields. The activities will NOT be open during these sessions, and you are not permitted to use them.
- You may NOT enter any areas marked No Access, Do Not Enter, or areas with working farm equipment.

Rules:

Please remember that we are a real, working farm...

- Do not disturb flowers, vegetation, crops, displays, etc. including sunflowers and pumpkins. Nothing may be picked and used during your session.
- Do not drive your vehicles through our fields.
- All props must be carried to your photoshoot location. Props or equipment that cannot be carried easily should not be used.
- All photos should be “family friendly” in nature.
- Please supervise all children at all times
- Absolutely NO PETS are permitted on the farm for photos.
- All props must be removed upon departure.
- We require that all trash be removed from photo site.
- All photographers and clients must leave promptly by 7:30pm.

Please Note:

- Sunflowers and pumpkins are agricultural crops and therefore subject to weather, growing conditions, and ripening variables. We cannot guarantee what they will look like on a particular date, so please prepare to be flexible with your visit.

Rain Policy:

- If we close for rain, we will AUTOMATICALLY refund your un-used session pass for that day. We are NOT able to refund the pass once you have ENTERED the farm. Passes that are un-used for any other reason are non-refundable.
